**15. Multidisciplinary / interdisciplinary**

**A. Delineate the vision/plan of institution to transform itself into a holistic multidisciplinary institution.**

The College is consistently endeavoring for the holistic growth and all-round development of the students. Inclusive approach by imparting education in areas different from that which is specified in the Curriculum.

In this regard, many initiatives have been taken by the College on a regular basis.

- A Committee has been constituted with a vision plan to ensure multidisciplinary education within and outside the college.
- As per the recommendations of the Committee, multidisciplinary Value Added Programs (VAP) are formulated and implemented, according to the New Education Policy (NEP). The objective is either advancement of the subject or providing exposure in a different domain.
- To encourage the students to use their creative skills and put them into practice through fundamental research techniques that will boost their confidence and skills in becoming entrepreneurs.
- To inspire faculty and students to submit patent applications and publish research articles.
- To sign MoUs with various foreign bodies to conduct student exchange programmes and provide appropriate exposure to the students.

**B. Delineate the Institutional approach towards the integration of humanities and science with STEM and provide the detail of programs with combinations.**

The following steps have been taken by the institute for assimilating Humanities with Science:

- The college organizes programs to integrate humanities and science by arranging presentations, workshops, seminars, and lectures to inculcate basic scientific knowledge among the humanities students.
- To ensure learning and development to the students which are from non-science stream are given the opportunity to attend value added course/ Workshop on Artificial Intelligence, Python, Java, etc. were also held for other students.
- The students not from Science are also provided an exposure and insights of scientific knowledge and facts by organizing Science Quiz Contest.
- The students of arts stream are taken for a visit in the museums to know and see about the ancient age royal lifestyle.
- Flexibility provided to humanities and science students by offering a variety of courses that link the various facets of the various disciplines like psychology, geography, economics, etc.

C. Does the Institute offer flexible and innovative curricula that includes credit-based courses and projects in the areas of community engagement and service, environmental education. Explain.

As a matter of practice, the institute offers Curricula assimilating courses which provide credit to the students. This is exclusively ensured for involvement in community-based activities and services.

Various credit-based and value-based courses and projects are organized to instill in students the values of a responsible citizen. So far, events such as blood donation camps, Re-thread (ramp walk for underprivileged children), Swachh Bharat Abhiyan awareness programs, Hair donation, Vriksh Mitra Saptah, and others have been held on campus. We also offer various soft skills courses, mock interview sessions, and workshops.

Visits to near-by rural areas and slums were done by students under Unnat Bharat Program. Anandam is introduced in curriculum as compulsory paper to develop moral responsibility along with credit system. Further, B.Voc and M.Voc courses are credit based and involves project work.

D. What is the institutional plan for offering a Multidisciplinary Education? Explain.

In view of the NEP, the College has initiated process of establishing new interdisciplinary centers integrating different

departments in addition to the existing inter/multidisciplinary research and academics. The institute has already started taking important actions in this regard and has constituted an exclusive Committee for proper execution of National Education Policy-2020.

The college has taken the initiative of ensuring a minimum desired level of multidisciplinary across all its programmes through awareness program amongst its faculty & students.

On completing A Level course of any program, the students are granted 30 Credit points in I year along with a certificate. Further, on completing Advanced Level of the program i.e. B level of the same course, another 30 Credit score will be provided to the learners. Finally, on completing a Diploma level in the same, 30 Credit would be added further.

The best part is that student can take entry into the course and thereby take exit after 30 credits.

E. What are the institutional plans to engage in more multidisciplinary research endeavors to find solutions to society's most pressing issues and challenges?

To foster an environment for ethical, cultural, and spiritual values among the students and staff in finding solutions to society's most pressing issues and challenges, a variety of activities are organized, such as nukkadnatak on sensitive topics of society, visits to the nearby villages and slums by the NSS team, visits to orphanages, and old age homes.

- The students observe various days of social significance like 'International Women's Day' for making the students realizing the importance of women empowerment.
- The college organizes expert lectures on issues related to environment and ecosystem for students of other streams.
- In the start-up event organized by the college the students from Science and Arts participated with great zeal.
- In addition, various major Research Projects were completed through DST, Government of Rajasthan.
- Moreover, numerous Minor Research Projects were completed through University Grants Commission (UGC).

F. Describe any good practices of the institution to promote Multidisciplinary/Interdisciplinary approach in view of NEP 2020.

The College discussion with the faculty members initiated on key

principles of NEP. Some of the good practices of the institute to promote multidisciplinary approach include:

- As per the area of interests, irrespective of their domain, the college students are associated with various clubs like Literary and Management Club, Cultural Club, Sports Club, Digital Marketing Club, Creative and Design Club, IT Club. The nominated Presidents, Vice Presidents and members of the various clubs take a lead in organizing and managing various club activities right from the beginning to the end. Such initiatives denote Good Practices because they develop sense of responsibility, leadership skills and accountability amongst the students from a young age.
- In addition, the students are given training on enhancing their Soft Skills. The students are given interactive and activity-based sessions like Talk over Tea, Idea Presentation, Group Discussions, etc.

Not only this, the modules also cover sessions on Technical Training with different kinds of software, MS Word, Excel, CS specific PHP, Python, DBMS, OOP, C concepts etc.

The college has taken the initiative of ensuring a certain level of inter/multidisciplinary in most of its programs. The College has been organizing and will continue to hold sessions with various experts on NEP awareness and process amongst its Faculty members and the students.

Being affiliating college we follow the curriculum designed by University of Rajasthan, Jaipur and RISU, Jaipur. A core committee for Academic Bank of Credits, which has taken the meeting and sent the proposal to Board of Management (BoM). Thereafter, the given recommendations are published on the web site in the form of link for Academic Bank of Credit. Besides, the recommendations have also been shared with the concerned University.

Being affiliating college, we follow the curriculum designed by University of Rajasthan, Jaipur and Rajasthan ILD Skill University, Jaipur.

Linkages play an important role in internationalizing the campus and the institute is designed to provide an opportunity to the students to get global exposure as well as facilitate foreign students to get exposure to our country. The institute maintains strong links with many national and international institutes, MOUs have been signed with the Foreign Universities from Romania, Turkey, UK, France for Joint workshops, programs, Student exchange, Research studies and skill development.

Value added programs in English communication, digital marketing, c+ language, python, business analytics are being provided to the students in collaboration with London school of digital business, Pearson, and other foreign universities.

D. How faculties are encouraged to design their own curricular and pedagogical approaches within the approved framework, including textbook, reading material selections, assignments, and assessments etc.

Being affiliating college we follow the curriculum designed by University of Rajasthan, Jaipur. Although faculty members recommend amendments whenever and every ever required. The Institute is practicing various faculty centric learning approaches to enhance their learning ability including Seminars, Workshops. Encourage them to prepare Short Training Program, assignments, assessments, presenting papers, doing minor and major research projects, writing research paper and book chapter, webinars and Online Certification Courses to get the participative learning environment.: Faculties are made to develop Innovative teaching pedagogies based on experiential learning,

Faculties are given funds for doing research work. The College faculties make extensive use of online learning resources and well equipped laboratories. Many training and orientation programs and workshops are conducted for the faculty members. Besides they are given academic leaves to participate in the faculty development

programs, National & International conferences, seminars etc.

E. Describe any good practice/s of the institution pertaining to the implementation of Academic Bank of Credits (ABC) in the institution in view of NEP 2020.

In view of ABC, under Good Practices, a Digilock has been created and the link of the same has been shared with the students. Under this, all E-documents of the students are stored and whenever they are required, they can access them through the link.

### 17.Skill development:

1. Describe the efforts made by the institution to strengthen the vocational education and soft skills of students in alignment with National Skills Qualifications Framework.

1. The institution has taken numerous initiatives to strengthen Vocational Education and Soft Skills Training Sessions in accordance with the National Skills Qualifications Framework (NSQF). The institution tries to provide students with quality education, which foster their overall growth. Eventually, this would help considerably in shaping the careers of the students. The institute works relentlessly and seamlessly to support students in order to advance their professional skills and grow holistically. Graduation courses are offered with the option of selecting an integrated vocational curriculum, such as B.Voc. or M.Voc. allowing exceptional students to continue exploring their abilities and talents and groom themselves as professionals to step into the professional world. As a result, the students have diverse and varied career options before them.
2. Provide the details of the programs offered to promote vocational education and its integration into mainstream education.

In affiliation with Rajasthan Skill University, several skill development modules have been designed and integrated into the curriculum.

1. B.Voc provides three programs: Journalism, Interior Design, and Fashion Design , in the form of Degree, Advanced Diploma

and Diploma.

2. M.Voc
3. Collaborative programs in Business Analytics, design, web technologies and IOS technologies with Apple.
4. Programs on Full stack development, IOT, and machine learning are being provided with the support of a skill development agency.

1. How the institution is providing Value-based education to inculcate positivity amongst the learner that includes the development of humanistic, ethical, Constitutional, and universal human values of truth (*satya*), righteous conduct (*dharma*), peace (*shanti*), love (*prem*), non-violence (*ahimsa*), scientific temper, citizenship values, and also life-skills, etc.

Teachers not only follow but also teach essential ethics and principles to their students in order to instill positivity in them. This encompasses inculcation of good conduct and behavior, development of moral values, self-analysis, value clarification, and action learning. It

Humanistic Approach, Ethical Behaviour, Constitutional Morality and Universal Human values of Truth, Righteous Conduct, Peace, Love, Non-violence, Scientific temper, Citizenship values and Life Skills are developed through various teaching processes, such as regular Assessments, Personality Tests, Presentations, Quizzes, Debates, enhancing Body Language and Listening Skills, Team working, Stress Management, Oral Presentations, Problem Solving and Decision Making, Persuasion and Influencing Skills Group Discussions, Conflict Resolution and Mediation Mock Interviews, etc. National and international remembrance days and festivals are commemorated with delight and excitement regardless of caste, colour, religion, ethnicity, sex, economic, social, linguistic, and ethical principles.

1. Design a credit structure to ensure that all students take at least one vocational course before graduating

1. An economical and affordable integrated fee structure has been

designed in affiliation with the Rajasthan Skill University and the NSDC. Moreover, the students are provided with industry exposure as part of the same to encourage them to explore their interests in preparation for a wide range of professional opportunities. In addition, there is also the option of varying the length of the professional training, such as a Graduate Degree, Diploma or Advanced Diploma.

Engaging the services of Experienced Industry Experts and Master Crafts persons to provide vocational skills and overcome gaps *vis-à-vis* trained faculty provisions.

2. Several related Experienced Experts and Master Artisans have been invited to connect with the students, share their knowledge and also conduct various workshops to bridge the gaps that trained faculty arrangements have created. This is done to encourage students to identify and develop their interests in Integrated Vocational Courses and expose current students to the industry.

3. As previously indicated, students can choose between blended and on-campus modular forms of study to improve understanding and communication between the students and the teachers.

NSDC association is to facilitate this by creating a unified platform to manage learner enrolment (students and workers), skill mapping and certification.

4. Soft Skills Training classes were conducted online for the students to keep them updated, interactive, and connected to each other. Besides, various Drawing classes were also conducted based on the historical aspects of the society in order to educate children their relevance and significance in today's changing world.

5. Soft Skills Training classes are planned in such a manner as can be offered to the students through online or distance mode.

Describe any good practice/s of the institution pertaining to the Skill development in view of NEP 2020.

E. In view of NEP 2020, many initiatives were taken to enhance the skills of the students and make them more aware and how to avail the various career opportunities through introducing Vocational Courses,

Project and Field Work, Value Addition Courses, Internships, etc.

**18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)**

a) Delineate the strategy and details regarding the integration of the Indian Knowledge system (teaching in Indian Language, culture etc,) into the curriculum using both offline and online courses.

Besides the use of ICT tools by the teachers to impart knowledge to the students, there is a different approach that the faculties use to provide academic knowledge as well as to keep the students close to Indian culture. Various events were conducted to keep the students updated and aware of the Indian culture like Holi, Diwali, Eid, Christmas etc., further knowledge about traditions and rights & duties is provided by Origami workshop, Kathputli workshop, KaviSammelan, constitution day celebration. Every year, study trips and tours are organized for students from all disciplines to learn more about their topics in addition to the regular theory and on-campus practical studies.

b) What are the institutions plans to train its faculties to provide the classroom delivery in bilingual mode (English and vernacular)? Provide the details.

Despite the fact that the lessons are delivered bilingually, students who have trouble understanding the material due to language barriers are given extra attention and classes. They are also encouraged to participate in soft skills training to improve their communication abilities and learn the fundamentals of the language so that they may continue to interact with their peers. Faculty members are encouraged to participate in faculty development programme, orientation programme, refresher course to keep with cutting knowledge.

1. Provide the details of degree courses taught in Indian languages and bilingually in the institution.

The institute runs under undergraduate courses like B.Sc.,BA and B.Com in bilingually mode i.e. both in English and Hindi medium as per the university norms. Institute ensures that every student is able to understand the course better. Additionally, more interactiveactivities like debates, group discussions, presentations, and group projects are organized regularlyto keep the students updated and more confident. Compulsory additional language papers, i.e.,Hindi and English are added to the fundamental courses

for undergraduate students to make them proficient in the written and spoken languages.

Being affiliating college we follow the curriculum designed by University of Rajasthan, Jaipur. But understanding the importance of traditional knowledge number of activities are carried by institute.

Competitions/ seminar like hindi divas celebration are being conducted on the promotion of languages and culture. Design students visited villages to learn handicrafts, artisans, katputli making to keep culture and tradition alive. Further under Unnat Bharat programme students visited villages and work to maintain

Study trips (virtual visits) and webinars are organized for students to provide them with practical knowledge of traditional cultures and teaching methods.

Various guest lectures of prominent professionals and exposure have been organized for students and the B.Voc and M.Voc and humanities students to expose them to ancient Indian art and its contribution to the development and shaping of society. Teaching different art practices.

All the National commemorative days and festivals are celebrated with joy to spread the message of unity and harmony, followed by cultural events, nukkadnatak, and various webinars explaining and making students aware of the Indian tradition and culture and the diversity and unity of the nation.

e) Describe any good practice/s of the institution pertaining to the appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course) in view of NEP 2020.

In consideration of the NEP 2020, courses are offered both in

English and in Hindi. In order to help students, become fluent in both languages, general Hindi and English papers that are required have been introduced to the core curriculum. In order to keep students informed about the world, and state of affairs and to impart knowledge that is not included in the textbooks, students are taught beyond the traditional theoretical books, i.e., through YouTube and guest lectures. As Indian education system propagates all around development of the personality by developing self-awareness, self-management and self-regulation. Hence, experiential learning has been integrated in the teaching pedagogy.

Further, through the experiential learning process the learner actively engages in different techniques of high order thinking skills like posing questions exploring new solving problems being curious and creative in his or her approach analytical thinking skills help the students to apply theoretical knowledge practically.

#### **19.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

i. Describe the institutional initiatives to transform its curriculum towards Outcome based Education (OBE)?

i. OBE has been adopted by Poddar College since its inception. Following the pattern of Outcome-based Education a competition was organized on the theme 'Nature vs. Life' to manifest that the nature is beautiful but at the same time, it is devastated on account of human interference. Further, the students of the college have actively participated in an Oral Presentation in an International Conference and has received awards and also published chapter of the book.

Many inter-class and inter-collegiate activities are organized in the college, which provides a forum to the students to identify their talent and exhibit the same. For instance, by means Fashion Shows and Ramp Walk organized by the institute rendered opportunity to be a Fashion Model for some students. Another student got to be a RJ through the cultural events organized in the institute. Dance contests held in the college provided a student with good dancing skills an opportunity to become a Choreographer.

In addition, after attending a workshop on Resin art organized by the institute for the Interior Design students, the students developed creative and innovative utility items like clocks, chairs, tables, table tops, etc. Considering the outcome of this great creative endeavour, the college has proceeded further in this regard by applying to the concerned authorities to acquire patent of the



same.

Further, the IT students made an obstacle detecting stick for the blind in the IT event 'TechnoTrack'. The IT students also developed an Accident Victims' App with a smart chip. This could be of great use to the victims of accidents as at such time of crisis the entire health status of the victim can be accessed through this smart chip.

OBE in science stream students is reflected through their participation in conferences/ seminar giving oral presentation on their curriculum related topics and publishing book chapters and research papers. Further, they prepared number of products through waste.

Moreover, the college has also given the students extensive exposure to the business world and given them the opportunity to pick up new skills in addition to their curriculum through partnerships with various industry professionals, businesses, and online organizations. For providing students more opportunities and in-depth information, the college has signed many MoUs with several overseas organizations.

ii. Explain the efforts made by the institution to capture the Outcome-based Education in teaching and learning practices.

ii. The institution has made an effort to include the OBE in its methods of instruction and learning.

This is accomplished by blending practical and theoretical knowledge. The theoretical classes are methodically planned, so that after theoretical learning the students are involved in presentations, group discussions market survey etc., to express their knowledge and learning. This enhances their understanding and boosts their confidence. Furthermore, internal assessment is done for every student and on the basis of the same action plan and recommendations are provided to the students. Not only this, the student's theoretical and practical knowledge are evaluated through a variety of examinations, which helps them develop their high order thinking skills.

For example, in a project, natural soap was prepared using herbs and flowers to add texture, color and aroma. Products like bio-based colorant were created from floral wastes on being applied to fabric generates different hues of green, yellow, and pink. The impact analysis of the colorant, cost-effectiveness and viability makes it



a promising candidate for textile industrial set-up. Another student of the institute started his own start-up on Tie and Dye. Inspired by 'Master Chef' activity in institute a student started his own Bakery. One of the student initiated his Tea business in South. An IT student of the student has started his own IT company.

iii. Describe any good practice/s of the institution pertaining to the Outcome-based Education (OBE) in view of NEP 2020.

iii. OBE has been adopted by Poddar College since its inception. Outcomes have been appropriately defined for each course and are properly mapped and assessed for calculating the attainment of the same every year and same is used to plan the improvement in academic processes of the college in forthcoming years.

Outcomes are assessed and attainment analytics are used to enhance the academic quality. In future, the process outlined above would be further be strengthened and attainment levels would be continued to be closely monitored in order to modify the pedagogy and /or the evaluation, in line with NEP 2020 objectives.

Keeping the Institution's motto, "Education with a purpose to shape a better future" into consideration, use of ICT in the classroom with guest lectures are amalgamated. Thus it is ensured that the students get an exposure to the corporate world. Entrepreneurial hands-on activities that enhance students' involvement to convert their classroom learning into practice are highly encouraged by the Institute.

**Distinct mechanisms are used to validate outcome-based education (OBE).**

**Stage I:** At the beginning of a new session the subject teacher conveys the program objectives (PO) and its specific outcomes (PSO) along with Course Objectives (CO). In addition to this, each subject's faculty member informs the students about the scope of the subject, evaluation format, marking scheme (internal as well as external), etc. Internal assessment includes direct and indirect measures to assess the attainment of objectives.

**Stage II:** Several direct and indirect methods are employed to internally evaluate attainment through unit tests, mid-term, pre-university, multiple choice questions, open book tests, short answer questions, quizzes, oral tests, oral and poster presentations, assignments, and practical knowledge. External assessment is based on the result published by university examinations.

**Stage III:** To calculate the attainment levels of the courses, a threshold value of 49 percent is fixed. Students with 80 percent and above are categorized as A, 60 and above percent are categorized as B and students with 49 and above are categorized as C. Accordingly students are given extra classes and tutorial classes to advance and slow learners respectively. This is followed by re-evaluation.

**Stage IV:** Feedback is collected from stakeholders and necessary amendments, if required at the college level, were carried out, rest informed to the affiliating university.

- to expand health care and social upliftment activities in association with the neighborhood, NGOs, and Government entities, with our NSS team.
- To upgrade the ICT infrastructure on campus
- To transform the old syllabus into a multidisciplinary curriculum as per the New Education policy and implement NEP guidelines.
